A very responsible and noble profession, which gives you dual opportunities of a lucrative career option with service to the humanity at the same time. In modern day scenario and keeping in view of the acute scarcity of the trained nurses, the role of ANM has become even much crucial which will continue to change and expand in years to come.

Career Objective

The objectives of this programme is to prepare skilled and effective workforce of trained staff nurses who, under the direction of a registered nurse, is prepared to give basic nursing care at the community level/village with specific skills. About the Course

GENERAL NURSING MIDWIFERY (GNM)

General Nurses & Midwifery (GNM)

Introduction : General Nursing and Midwifery or GNM is a three-year and six-month diploma course designed for aspirants who want to pursue a career in clinical nursing. The programme teaches candidates how to care for individuals who are sick or have been injured in order to help them attain full recovery. GNM courses are designed to prepare the students for the clinical approach of handling patients.

Career Objective

This course help to prepare nurses with a sound educational programme in nursing to enable them to function as efficient members of the health team, beginning with the competencies for first level positions in all kinds of health care settings. This course ability to co-operate and co-ordinate with members of the health team in the prevention of disease, promotion of health and rehabilitation of the sick. During GNM students are able to make maximum contribution to the society as useful and productive individuals, citizens as well as efficient nurses.

Duration : Three Years

The Diploma course in General nursing and Midwifery is three years including 6 months internship.

Eligibility Criteria

10+2 with English and must have obtained a minimum of 40% at the qualifying examination and English individually for any recognized board. Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government. However Science is preferable.

10+2 with English having 40% of marks in vocational ANM course from the school recognized by Indian Nursing council.

10+2 with English having 40% of marks in Vocational Stream-Health care Science from a recognized CBSE board/Centre.

RULES & REGULATIONS AND IMPORTANT INFORMATION

Every effort has been made to ensure the accuracy of the information contained in this Prospectus and it is issued on the express condition that all matters in it are subject to change from time to time without notice. While IPH&H-SCHOOL OF NURSING, New Delhi will make all reasonable endeavors to deliver the courses of study and other educational services as set out in this Prospectus, circumstances may change prompting IPH&H-SCHOOL OF NURSING, New Delhi to reserve the right to vary the content and delivery of courses and programmes.

1. **Nature of the Program :** ANM & GNM are full time regular program in nature. The classes will be conducted daily (from Monday to Saturday, 09.00 A.M. to 04.00 P.M.). Timings of clinical postings/field visits to observation visits may vary from organization to organization and as per the time set by the organizations concerned.
2. **Training Methodology :** As per the guidelines of Delhi Nursing Council, the training will include theoretical sessions, practical lab sessions, clinical postings, field visits, observation visits, health camps, seminars and symposium etc. Medium of Instruction will be both Hindi & English. However, students can opt for Hindi medium as their preferred language and based on majority of the scholars, Explanatory notes/lectures can be arranged in Hindi only.
3. **Study Material :** All study material both in first and second year is against purchasing and available at the book counter of the school. Copy of the detailed syllabus as prescribed by Indian Nursing Council is available on payment of Rs. 100.
4. **Uniforms :** Students have to pay for their own uniforms. For practical hospital experience in the hospital ANM students wear Pink Checked Shirt and Blue Trouser with white apron. Length of apron is mid thigh with a collar and side pockets, with Black Close Shoes and white socks.
5. **Conduct of the Student :** Conduct of the students in their classes, as well as in premises of the School, Hostel and in the area, must be such as cause no disturbance to fellow students of the other classes. The students are not allowed to use alcohol, or to attend training classes under the influence of any type of intoxicants i.e. Tobacco, Barbiturates etc. in premises of the Hostel and the School. Maintenance of cordial & friendly atmosphere is necessary in the School, in Hostel & other premises. Use of Pan, Pan-Masala or Gutka or Chewing Tobacco or snuff and smoking of Cigarettes, consuming Alcohol, Sedatives or any Drugs etc., are strictly banned in the IPH&H-SCHOOL OF NURSING and in its Hostel premises.
6. **Security & Entry into-the IPH&H-SCHOOL OF NURSING and its associated Premises:** Security personnel have been deployed at different points to check unwanted entries and to avoid unpleasant happenings in premises of the IPH&H-SCHOOL OF NURSING and they have been directed to check Identity-Card, Bags, and Briefcases etc. Hence, all the students of the school are requested/advised not to exchange bad language or arguments with the security personnel at any point.

The students are advised/requested not to keep any Knife, Razors or any objectionable arms and, while entering into the premises of the IPH&H-SCHOOL OF NURSING or in its Hostels, otherwise, necessary and suitable Legal/Police action will be taken against the defaulters.

The students are also advised/requested neither to use abusive or indecent languages or indulge in or make any hot arguments nor discuss the political or religious issues with their colleagues and staff in the premises of the IPH&H-SCHOOL OF NURSING or outside the premises to avoid any unpleasant happening.

The students are required to carry their Identity Card and Medical Assistance Card during their Theoretical Classes, Field Practical & Internship Training as well as Educational Tours, organised by the School.
7. **Change of Address :** Notice for change in address should be given by the candidate/student to the Office in writing immediately.
8. **Damage to Property :** Students/Candidates shall do nothing either inside or outside the School that will in anyway interfere with its orderly administration and discipline. Non-compliance with the rules of the School, may be dealt with, by means of suitable fines and punishment. Students are expected to take proper care of the movable & immovable properties of the School and if any damage is caused to the property as a break i.e. disfiguring of walls, doors, fittings, and breaking furniture etc., it will be considered indiscipline and culprits will be duly punished. The students may be charged for loss or damage to property or equipment caused by her carelessness, negligence or misuse. The students are expected to take proper care of the property of the School and to keep the premises neat, clean and tidy.
9. **Attendance :** 90% Attendance in the theoretical and practical/training classes is the compulsory condition for appearing in the First Term Exams/Internal Assessment of the School and Term End Exam of the Delhi Nursing Council. Further, student will not keep herself absent from the theoretical/practical lab sessions without prior permission or intimation to the concerned officer of the School. Otherwise, disciplinary action will be taken against her. Students are expected & directed to abide by the Rules & Regulations and time schedule and no relaxation in the time schedule will be given in any case.
10. **Personal Property :** The School's authorities will not accept the responsibility for damage or loss of clothing and any other personal property in the Hostel & School Premises or grounds or outside the campus of the School. Students are strictly advised not to leave clothing or valuable articles or books/lecture notes etc. un-attended in rooms.
11. **Right of Admission Reserved :** Right of admission is reserved and the decision of the Management of the IPH&H-SCHOOL OF NURSING will be final in this respect. The Management of the School reserves the right to reject any application without assigning any reason.
12. **Medium of Examination :** The Question Paper will be in English language. However, the examinee will be at liberty to answer either in Hindi or English.



RULES & REGULATIONS AND IMPORTANT INFORMATION

13. **Payment/Refund of Fees, Fines & Dues etc.:** Payment of course, Exam. Fee & other charges in time or on demand is the responsibility of the candidate. In case of a candidate failing which, her name will be struck off from the rolls of the session without any notice and the fees paid by her will neither be refunded nor adjusted in any circumstances.
14. **Refund of Fee :** Fees, once paid, is neither refundable nor adjustable in any circumstances, which may please be noted very clearly. The School will not be responsible for any change in circumstances or family economic condition or conflicts, disputes or decision to discontinue the study or any reasons or in case, if a candidate is rusticated, from the School.
15. **Payment of Dues :** All dues shall be cleared by the dates mentioned in the Prospectus/Office order etc. or as notified by the Management of IPH&H SCHOOL OF NURSING. Names of the candidates defaulting to pay the dues within 20 days will be struck off from the rolls of the IPH&H-SCHOOL OF NURSING.
16. **Late Fees/Fine :** If the dues other than those payable at the time of admission are not paid by the due date, a late payment fine of Rs. 5/- for each day after the due date (including holidays) shall be realised subject to a maximum of Rs. 500/- only.
17. **Payment-Fine & Dues :** Students shall have to pay on demand any fine imposed on her or the cost of any damage or loss of library books, equipment or other School's property movable or immovable. On failure to do so, the same will be recovered from their Security Deposit which shall be reimbursed to the student within the time-specified by the School. If the cost of any damage to be recovered or loss exceeds the amount of Security Deposit, the balance shall be deposited by the student or her parent / guardian on demand by the School. Failure to do so may result in the removal of the student from the rolls of the IPH&H-SCHOOL OF NURSING. All dues of the School must be cleared by the students before they are permitted to appear in the Examination. If the dues are not cleared, their Admit Cards/Provisional Certificate/Original Diploma will be withheld.
18. **Terms of Payment :** All fees are payable in advance and strictly either in Cash or through a Crossed Bank Draft made in favour of the 'Institute of Health & Hygiene', and payable at New Delhi' as per schedule.
19. **Striking of the Roll/Cancellation of the Admission:** The name of the student may be struck-off from the rolls on account of:
 - (i) Her own request endorsed by her parents/guardian;
 - (ii) Continued absence without obtaining leave for Six (06) working days;
 - (iii) Irregular attendance and poor progress in studies;
 - (iv) If her behaviour, character or activities are not satisfactory.
 - (v) If ordered to be expelled or rusticated from the School.
 - (vi) Causing damage to the goodwill & prestige of the School.
 - (vii) She has been found in a habit of consuming Alcohol/Barbiturates or any other sedatives and
 - (viii) She is found indulged in any anti-social / illegal / criminal procedure of Law or any FIR has been lodged against her
 - (ix) Found medically unfit to continue the program or having an epidemic of communicable nature during the course of study
 - (x) If any applicant who is offered admission does not report within the date specified on the notice of admission the offer will be treated as cancelled and the seat will be offered to the next eligible applicant from the merit list
 - (xi) If Any Information/Certificate Supplied By The Applicant In Connection With Her Admission Is Later On, At Any Time, Found To Be Incorrect Or Falsified It Will Result In Cancellation Of The Admission Of The Student From The School

UNDER ANY CIRCUMSTANCES, THE FEES WILL BE REFUNDED OR ADJUSTABLE AND NO DEGREE/ DIPLOMA/CERTIFICATE OF LESSER DURATION WILL BE ISSUED, IF A CANDIDATE IS RUSTICATED FROM THE SCHOOL.

20. **Accommodation In the Residential Facility :** Students willing to opt for residential facility, shall have to fill-up the Application Form for residential accommodation and at the time of admission only and submit the same to the School along with the residential charges, certificate of physical fitness signed by Medical Officer of the School. She shall have to live in the residential facility up to the Final Examination. She will not be allowed to leave the residential facility mid of the session.

It is made clear to the Parents/Guardians that the School is not responsible for the undesired activities/leaving the School /Residential Premises without the permission of the concerned authorities of the School/ Resident In-charge, any activities / habits of the students which may cause her any physical or mental trauma.

However the School provide proper security to the students availing residential facility, the School will not be responsible for any untoward incident, medical emergency or in case if the student leaves the campus or residential area without proper permission or after misguiding the officials of the School.

It is advised that the parents, desiring of putting their ward in residential facilities to provide minimums possible list of authorized visitors, local guardian.

In case if any student is reported to be disobeying the instructions, rules & regulations she shall be rusticated from the residential facility as well as from the School and fee / charges paid shall be forfeited and the decision of the Management shall be binding on the student and her legal guardian. Rusticated students have to vacate the residential facility within 24 hours of rustication.



RULES & REGULATIONS AND IMPORTANT INFORMATION

21. **Fitness Test** : Nursing is physically demanding profession. Therefore, It is mandatory for Parents/Guardians to submit a medical fitness certificate from a medical officer having no less than MBBS degree. They also need to submit a declaration about the fitness of their ward. If there is any infection or disease that had occurred in past or present with the ward, it must be mentioned in a clear and detailed manner in the declaration to enable the School's Management to take precautions and proper care for the same.
22. **Residential Facility** : Accommodation is available, on request & on payment of Rs. 6,500/- per month (Accommodation & Mess Charges) per candidate in the accommodation for Boys & Girls (separately) at New Delhi Training Centre of the School. Every candidate shall have to remit Rs. 2,500/- per year as consumable charges (Non refundable). Accommodation will be available on the "FIRST COME FIRST SERVE BASIS" principle.
FACILITIES : The students are provided Homely environment Comfort Mess and Common hall Provision Store PCO Intercom for incoming Calls Healthy Educational Environment Laundry (On Demand) Security 24 hrs. Electricity & Power Supply Hot water supply in winters Vehicle for local Shopping Health Care Services. From time to time, the hostellers are also taken out for Picnics & on Educational tours in and around Delhi on share basis.
The candidates shall have to pay all the revised monthly charges as per new Session's Information. Brochure / Prospectus every year.
23. **Character & Behaviour of the candidate in the Residential facility**: The candidates shall have to maintain high standard of character, hygiene, social and mutual behaviour during their stay in the Hostel of School.
24. **Other Charges** : Every candidate shall have to pay/remit the following mandatory charges at the time of confirmation of her admission:
 - (i) Uniform Charges: Approx Rs. 2,500/- or as applicable at the time of admission
 - (ii) Books Charges: Approx Rs. 2,500/-per year or as applicable at the time of admission
 - (iii) HIV/AIDS Conference participation fee - Rs. 1000/-(Approx.) Please Note: The Fee or above said charges if once paid, are neither refundable nor adjustable, in any circumstances.
25. **Right to Call Parents/Guardians** : The Secretary/Director/Principal of the IPH&H-SCHOOL OF NURSING are authorised and competent to call the parents/guardians of the students in the office of the IPH&H-SCHOOL OF NURSING or in its associated Organisations/Trust/Society/Hospital/ Nursing Homes in case :
 - (i) If the attendance of the student is less than 90% in any month;
 - (ii) If the student has developed a habit of keeping himself/herself absent from the classes without any intimation or permission;
 - (iii) if her behaviour of action may cause/ has caused/ is causing damage to the movable or immovable property, prestige & reputation of the IPH&H-SCHOOL OF NURSING and its Associated organisations, (iv) If her behaviour or character is not satisfactory or up to the mark
 - (v) If she has not paid the course Fees, Examination Fees, Hostel and Mess Charges, and
 - (vi) She has developed the habit of ignoring instructions issued by any authority of the IPH&H-SCHOOL OF NURSING, New Delhi.

No. T.A./D.A. will be paid to the parents/guardians of the students, if called for meeting/ discussion.
26. **Field Practical Training** : The students need to attend the clinical postings, seminars, observational field visits, internship/practical training etc. at their own conveyance/ expenses
27. **Change of Program is not permissible** : No Change of Program is permissible under any circumstances.
28. **Employment Assistance** : The School is also providing Employment Assistance to the candidates, who successfully qualify the ANM program. Candidates can apply on the Proforma available in the Office for registration of their name for Employment Assistance. But the IPH&H-SCHOOL OF NURSING, New Delhi does not guarantee or assure employment in any sector viz. Govt./Semi Govt./Private etc. in this context
29. Formation & Collaboration / joining of illegal Unions / Councils / Welfare / Associations of students are not allowed, and the candidates shall have to follow the high standard of moral and ethical values in life and practice during their stay, classes and training period in this School.
30. The students are not allowed to indulge in any anti-social or any anti-religious activities and not to keep any arms and/or ammunition items during their stay and study in campus & hostel.
31. **Anti Ragging Policy** : As per the directions by the Honourable Supreme Court of India, ragging in any form is strictly prohibited in educational institutions. In case, if any student is found ragging /harassing other candidate, she will be rusticated and booked under law. Every student and her Parent/Guardian shall provide affidavits affirming to the effect that she has not been expelled and/or debarred by any institution for any act of ragging and further that she will not indulge actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/or abetting ragging will be liable for suitable action by the management of the School.
32. **No Smoking Zone** : The Min. of Health & Family Welfare, Govt. of India, has banned smoking in public places/Educational Institutions. Therefore, all the students are directed not to smoke in the campus or hostel of the School. Any student found doing so will be booked under the law.
33. The School reserves the right to amend previously announced fee and/or rules & regulations, if necessary from time to time and without any prior information/notice.

Examination & Attendance:

1. During the 1st & 2nd year there will be Internal Term Examinations in theory and practical's which will be conducted by the School. The passing marks will be 50% in each subject as per the Delhi Nursing Council (DNC) regulations. The results of internal assessment will be sent to the DNC along with application forms for appearing for the External Final Examination.
2. Candidates must pass internal examinations before being sent for first & second year final examination conducted by DNC, New Delhi.
3. There will be theory & practical examination held by the DNC, New Delhi at the end of First year and at the end of the course.
4. A candidate failing in maximum of two subject will be promoted to the next year. She has to appear for the final as well as supplementary exam. Unless she clears the subject her final result will not be declared. Student failing in more than two subjects will be detained.
5. Supplementary examination will be conducted at six monthly intervals for the failures. Maximum duration of completion of the course 4 yrs.

Attendance : Students are expected to attend all the theory & practical classes regularly. 80% attendance in all theory classes and 100% attendance in practical/clinical classes is a mandatory criteria for ANM students. Pertinent to mention that only those students will be allowed to appear in the Final Examinations to be conducted by Delhi Nursing Council who fulfils the above criteria The student has to make up the shortfall in attendance at the end of the course to attain 100% attendance as required for the award of diploma by the Delhi Nursing Council.
